III. Minutes

- Jeff Thomas moved that the minutes from the 8/21/23 meeting be adopted with the edit that the trailer be described as "light" but not "quite light." Mike Kaiser seconded the motion, and the motion passed unanimously.
- \bullet Jeff Thomas moved that the minutes from the 10/9/23 meeting be adopted as written. Em Thiessen seconded the motion, and the motion passed unanimously.

IV. Special Announcement

• Joel Harris is the Volunteer of the Year! Joel is completing his 8th year on the board and has logged many hours of volunteer service at Vig events, culminating in his role as Sun Run Race Director (2022, 2023). He has a special connection to that event, having attended all 8 editions and raced in the first 7 (including a win in 2017). He has authored

write-ups for the Montana Cup, serves as the "Speaking of Running" program director, and volunteers for other groups like the Last Chance Nordic Ski Club. Pat presented him the traditional "Wheaties Box Award" pending the preparation of the official 2024 plaque.

• Distinguished Vigilante Award – nominations are open for the 2024 award! (done)

V. Financial & Membership Report – Ann, Ben, Pat

- Current Assets (11/20/23): \$71,096.19 vs \$48,443.47 last year
 - this includes the \$30,000 invested in CDs
 - this balance will drop with upcoming credit card payments, etc.
 - Ann noted that she successfully bumped the daily credit card limit to \$7500 and will continue to apply for higher limits
 - Ann will also investigate opening a Vig Venmo account initial research suggested it probably wasn't worth it but Jesse has expressed renewed interest for Novas purposes
 - the first CD matures on 12/1

the group agreed to re-invest the \$15,000 in a one-year CD, <u>assuming</u> the interest rate is still 5.0% or higher on that day (otherwise, the group will be polled via email) - done

- Current Membership (11/20/23): 80 vs 69 last year; \$3325 of \$6000 raised
 - Ben is optimistic that we will hit our target of 150 by December 15
 - "Board Member Challenge" google sheet is live!
 - Giving Tuesday is November 28!

VI. 2024 Budget (see attachment below) – Pat, Ann

- Pat proposed adopting the annual HVR budget before the start of the fiscal year
- the presented budget is conservative (i.e. "semi-worst-case" with expenditures)
- the club's reserves are sufficient to cover the \$6,633.92 "deficit" if it were to occur
- in reality, Pat expects that the club will finish 2024 with a "profit" as we always have
- but this budget allows the club to spend "up-to-those-amounts" in 2024 without having to seek additional board authorization
- idea: online store for the "swag" item this year; people can choose their membership item
- after some further discussion and Q&A, Ann Seifert moved adoption of the proposed budget with the following changes:
 - 1) \$50 instead of \$20 for "MT SOS Corporate Filing Fee"

(to allow for the application of a MT Cup service mark)

2) \$1000 instead of \$558 for "Porta-John for the Track"

(to allow for additional months)

(Jesse said Novas budget can also pitch in if needed)

(Jeff will contact Littl John's about winter functionality)

- Jesse Zentz seconded the motion, and the motion passed unanimously
- Pat noted that it would also be good to adopt an official Financial Policy in 2024

Addendum – Post-Meeting Interim Board Activity (especially votes, usually e-votes)

- On 1/1/24, a motion was made to select David Curd for the "2024 Distinguished Vigilante" award. The motion passed unanimously.
- On 1/16/24, Erik Makus made a motion to compose and send a letter on behalf of HVR to MT DOT "to connect the North Benton Trail (along the east side of Benton) to both Batch Field parking lot (so as to connect to the Nature Park trail on the east side), and also extend it up the east side of the road to the Centennial Park connector (which is on the east side). Stopping a trail half a block short of connecting to another trail makes no sense, and forcing a dangerous crossing of Benton TWICE in one block to get to Centennial trail (with no stop lights/stop signs/minimal lighting at night), seems like a dangerous situation for runners that could easily be fixed." The motion passed with additional support from French, Judge, McLane, Quiñones, Stergar, Thiessen, Thomas, Urban, Young, and Zentz (11-0).
- On 1/26/24, Pat Judge moved that HVR petition the Secretary of State to update our classification to "public benefit corporation with members" for a nominal filing fee of \$15. The motion passed with additional support from Harris, McLane, Quiñones, Seifert, Thomas, Urban, Uribe, and Young (9-0).
